

WEMW 2026 GREEN LOTTERY - TERMS AND CONDITIONS

Art. 1 – Purpose

The WEMW Green Lottery is promoted by the Fondo Audiovisivo FVG on the occasion of the 16th edition of *When East Meets West* (WEMW), with the sole purpose of raising financial resources to be allocated to the compensation of part of the carbon dioxide (CO₂) emissions generated by the participants' travel.

Art. 2 – Organizer

The organization and management of the lottery are the exclusive responsibility of the Fondo Audiovisivo FVG, with registered office at Via Asquini, 33 – 33100 Udine (UD), VAT No. 03053330308 – Tax Code: 94118460305.

Art. 3 – Duration

The lottery will take place on January 19th 2026 and January 20th, in conjunction with the 16th edition of *When East Meets West* (WEMW).

Art. 4 – Participation

Participation is open to natural persons who are at least 18 years old on the date of registration and who purchased one or more Green Lottery tickets on WEMW website or who have purchased a WEMW 2026 Accreditation.

Art. 5 – Prizes

The prizes, awarded by random draw, consist of:

- Stay of 2 nights for 2 guests at **Pineta Nature Resort - Wellness & SPA**, located in Trentino, including overnight stay, breakfast, Nature SPA services and outdoor activities.
- Stay of 1 night for 2 guests at one of **Friland's** locations, located in Friuli Venezia Giulia, including overnight stay and breakfast.
- 8 accessories, either bags or backpacks, by **GOTBag** - made with recycled materials such as Ocean Impact Plastic.

Art. 6 – Drawing and Awarding of Prizes

The draw will take place on Monday January 19th and Tuesday, January 20th, at 19:30 CET, at the Library of the Savoia Excelsior Palace Hotel in Trieste, in the presence of a representative appointed by the Fondo Audiovisivo FVG, who will

ensure the regularity of the proceedings.

Winners will be informed directly during the draw and via email sent to the address provided during registration.

Art. 7 – Processing of Personal Data

The personal data collected will be processed in compliance with Regulation (EU) 2016/679 (GDPR) and applicable national legislation, exclusively for purposes related to the management of the lottery, the organization of the WEMW 2026 event, and to fulfill legal obligations.
